On 10th April 2025, at 9:00 AM, expired the deadline for submitting offers in the procedure conducted in the form of a request for proposal, based on the provisions of § 4 of Order No. 2 of the Dean of the Faculty of Psychology of the University of Warsaw as of 1st February 2021, regarding the internal procedure regulating public procurements with a value not exceeding PLN 50,000 and the provisions of Order No. 294 of the Rector of the University of Warsaw as of 31st December 2020, regarding the procedures, principles and forms of awarding public procurement contracts by the University of Warsaw for services, supplies and construction works and organizing competitions (UW Monitor item 519, as amended).

The provisions of the Act of 11 September 2019 - Public Procurement Law (consolidated text: Journal of Laws of 2024, item 1320) do not apply to the conducted procedure, due to the content of the provision of art. 2 sec. 1 item 1) of the aforementioned act.
